

# Rental Terms & Conditions

**1. I understand Japan's traffic regulations.**

**2. I have a driver's license that allows me to drive in Japan.**

**3. I understand the terms of ORIX Rent-A-Car renter insurance as well as my deductible.**

Renter Insurance

Rental cars are insured within the following coverage limits.

- Bodily injury: Unlimited per person (including automobile liability insurance)
- Property damage : Unlimited per accident (50,000 yen fee will be incurred for exclusion of liability)
- Car damage: Up to the actual value per accident (50,000 yen fee will be incurred for exclusion of liability)
- Physical disability : Up to 30 million yen per person

Note: Payout will be made for injuries to passengers (including death and residual disability) regardless of who is liable. Damages will be calculated by the insurance company based on the insurance policy.

• Collision Damage Waiver (CDW)

CDW assures waiver of renter's full co-payment in the insurance payout.

Note: Seat-belt use is required.

• Non-Operation Charges (NOCs) (tax-exempt)

• Should an accident, theft, trouble, damage, etc., occur that is not ORIX Rent-A-Car's responsibility, and repair and cleaning of a vehicle are required, the renter must pay the following compensation for business losses incurred by ORIX Rent-A-Car due to inoperability of rental car.

• Renter drops off the rental car at reserved rental site: 20,000 yen

• Rental car is inoperable and cannot be dropped off at reserved rental site: 50,000 yen

• Rental Car Assistance Pack (RAP)

RAP entitles you to exempt payment of accident-related NOCs as well as the cost to repair or replace flat tires.

**4. I choose the following coverage(s) during the term of my rental.**

**5. I understand and agree to co-payment of any traffic violation.**

• I must promptly appear at the police station in whose district a ticket for illegal parking has been issued and complete all required procedures.

Furthermore, I will pay a penalty to ORIX Rent-A-Car if I do not provide at drop-off time a receipt for payment of a parking or traffic violation.

Note: Violations include speeding and failure to observe seatbelt law.

**6. I understand I must check the vehicle (for scratches and other irregularities) in the presence of staff at pick-up time.**

**7. I understand that I must personally conduct pre-operation inspection of a rental car on and after the second day of rental.**

**8. I understand the following required procedures in the event of an accident.**

Accident : 1. aid the injured; 2. while onsite, report the accident to the police; 3. confirm the name and documentation of the other party; and 4. contact the translation center.

Car problems: If a vehicle breaks down or any problem occurs, stop driving and contact the translation center.

**9. I understand that I must pay the balance due if I must rent a bigger vehicle when the reserved car is too small for my luggage, or for any other reason.**

Note: Accommodating your request will depend on the availability of vehicles.

**10. There are three types of fuel: regular, high octane and diesel. Check fuel type for your rental car.**

A vehicle may be damaged when the wrong type of fuel is used.

I will pay for the cost of repairs incurred due to use of the wrong type of fuel.

**11. I will rent a car having understood ORIX Rent-A-Car Contract details and the usage guide.**
